Privacy Notice Personal Data Protection Kajang Municipal Council

(Revised as at 30th September 2022)

1. Introduction

- 1.1 We, Kajang Municipal Council (MPKj), a Local Authority established under section 3 of Local Government Act 1976 (Act 171) of Malaysia, are committed to protect your privacy in accordance with the Personal Data Protection Act2010 (Act 709) of Malaysia. This privacy notice explains:
 - i. the type of personal data we collect and how we collect it;
 - ii. how we use your personal data;
 - iii. the parties that we disclose the personal data to; and
 - iv. the choices we offer, including how to access and update your personal data.

2. Personal data we may collect from you

- 2.1 We may collect the following personal data about you:
 - personal information to establish your identity and background such as your full name, passport or identity card number, nationality and religion;
 - ii. contact information such as billing address, premises address for electricity supply, telephone number, mobile phone number, fax number and email address;
 - iii. payment information such as your debit or credit card information, including the name of cardholder, card number, billing address, expiry date and other bank account details;
 - iv. sensitive information such as your racial or ethnic origin, political opinions, religion or other beliefs, health, criminal background or trade union membership. We do not generally collect sensitive information

- unless it is necessary due to exceptional circumstances to serve you better and meet your particular needs;
- v. recording of your image via CCTV cameras installed at our office building, branches or premises;
- vi. recording of your photograph during any of our corporate events or third party open day;
- vii. recording of calls placed by you to us;
- viii. function or post when you commence a business relationship with us; and/or
- ix. resume or curriculum vitae when you apply job with us.
- 2.2 For general web browsing although no personal data is revealed to us, certain technical and statistical information is available to us via our internet service provider such as cookies, your IP address, the time, date and duration of your visit.
- 2.3 If you provide us with any personal data relating to a third party (e.g. information of your spouse, children, parents and/or employees), by submitting such personal data to us, you represent to us that you have obtained the consent of the third party to provide us with their personal data for the purposes as listed in this privacy notice.

3. How we collect your personal data

- 3.1 We may collect personal data either from you, from your authorized representatives, from third parties or from publicly available sources which may include (but is not limited to):
 - i. when you are the owner or occupier of any holding within our area;
 - ii. when you sign up for any of our services;
 - iii. when you contact us in person, by a phone call or over the counter (for example when you contact us for any enquiries, complaints, comments or feedbacks, we may keep record of that correspondences);

- iv. when you participate in any surveys, questionnaires, competitions, contests, offers or promotions done internally or via an appointed third party;
- when you commence a business relationship with us (for example, as a service provider or business partner);
- vi. when you visit our office building or any of our branch offices;
- vii. when you attend any of our corporate events or third party open day;
- viii. when you visit or browse our websites;
- ix. when you apply job with us;
- when you interact with us via social media or interactive applications including but not limited to Facebook, Twitter and Instagram;
- xi. when we initiate legal action against you;
- xii. when we collect information about you from third parties we dealt with or are connected with you (payment collector, housing developer, credit reporting agencies or financial institutions); and/or
- xiii. from such other sources where you have given your consent for the disclosure of personal data relating to you and/or where otherwise lawfully permitted.

4. Use of personal data collected

- 4.1 You agree that we may use your personal data where permitted by applicable law and for the following purposes:
 - i. to verify your identity;
 - ii. to manage and maintain your account or contract with us;
 - iii. to notify you about benefits and changes to our services;
 - to provide and improve our services to you including fulfilling audit requirements, billing for services and facilitating payments;
 - v. to carry out your instructions or to respond to any enquiries, complaints, comments or feedbacks that you have submit to us;
 - vi. to protect or enforce our rights to recover any debt owing to us;

- vii. to compile information for analysis and in reports for relevant regulatory authorities;
- viii. to transfer or assign our rights, interests and obligations under any of your agreements with us;
- ix. to update, consolidate and improve the accuracy of our records;
- x. to administer competitions, contests, offers or promotions;
- xi. to produce data, reports and statistics which have been anonymised or aggregated in a manner that does not identify you as an individual;
- xii. to conduct research for analytical purposes including but not limited to data mining and analysis of your transactions with us;
- xiii. to assess financial and insurance risks:
- xiv. to conduct surveys, questionnaire, and provide you with information from us or which we feel may interest you, where you have consented to be contacted for such purposes;
- to engage in business transactions in respect of services to be offered and provided to you;
- xvi. to comply with any legal or regulatory obligations under the applicable laws, regulations, guidelines or industry codes that applies to us;
- xvii. for internal management of the services being provided to you;
- xviii. to maintain records required for security, claims or other legal purposes;
- xix. to provide training for our staff;
- xx. to conduct marketing and information technology activities (for example, market research);
- xxi. to persons who have been identified as being you or your authorised representative(s) pursuant for the purpose of the relevant transaction or enquiry;
- xxii. to third parties with whom we have contracted to provide services to us (such as analysis on our behalf) for any of the purposes described above. Where we disclose your personal data to third parties we shall ensure that such data is used only to provide services to us; and/or
- xxiii. for any other purposes that is required or permitted by any law, regulations, guidelines and/or relevant regulatory authorities.

5. With whom we share your personal data

- 5.1 As a part of providing you with our services and the management or operation of the same, we may be required or need to disclose information about you to the following third parties:
 - i. Federal or State Government:
 - ii. law enforcement agencies;
 - iii. government agencies;
 - iv. regulatory authorities; ANGOR
 - companies or organisations that act as our agents, contractors, service providers or professional consultant;
 - vi. companies or organisations that assist us in processing and/or otherwise fulfilling transactions and providing you with services that you have requested;
 - vii. our business associates and other parties for purposes that are related to the purpose of collecting and using your personal data;
 - viii. other parties in respect of whom you have given your express or implied consent; and/or
 - ix. any credit reporting agencies or in the event of default, any debt collection agencies subject to the permitted law applicable to us.

6. If personal data provided by you is incomplete

- 6.1 Where indicated in our application or registration forms manually or electronically, it is obligatory to provide your personal data to us to enable us to process your application for our services.
- 6.2 Should you fail to provide a complete and obligatory personal data, we may not be able to process your application or provide you with our services.

7. Your rights to access and correct your personal data

- 7.1 We can assist you to access and correct your personal data held by us.
- 7.2 Where you wish to have access to your personal data in our possession or where you are of the opinion that such personal data held by us is inaccurate, incomplete, misleading or not up-to-date, you may make a request to us to amend your personal data.

8. How long we will keep your personal data

8.1 We will retain your personal data in compliance with this privacy notice and/or the terms and conditions of your agreement(s) with us for the duration of your relationship with us, for such period as may be necessary to protect our interests as may be deemed necessary, where otherwise required by the law and/or where required by our relevant policies.

9. How we protect and safeguard your personal data

- 9.1 We endeavour to take all reasonable steps to protect your personal data and keep your personal data secured.
- 9.2 Our site may link to other websites and we are not responsible for their data policies, procedures or their content.

10. Disclosure and transfer of your personal data

- 10.1 Any personal data, which voluntarily given to us, will be treated with the highest standards of security strictly in accordance with Act 709.
- 10.2 We do not disclose your personal data to unauthorized third parties without your consent.

- 10.3 However, we will disclose your personal data if required to do so by law or in good faith, if such action is necessary to:
 - comply with the requirements of any law enforcement agency, court order or legal process; or
 - ii. protect and defend our rights or properties.
- 10.4 It may be necessary for us to transfer your personal data outside Malaysia if any of our service providers or business partners are involved in providing part of a services are located in countries outside Malaysia, you consent to us transferring your personal data outside Malaysia.
- 10.5 In the circumstances set out in paragraph 10.4 above, we shall take reasonable steps to ensure that any such service providers or business partners are contractually bound not to use your personal data for any reason other than to provide the services they are contracted by us to provide and to adequately safeguard your personal data.

11. Your consent

- 11.1 By submitting your personal data, you consent to the use of that personal data as set out in this privacy notice.

- 11.3 Your continued use of our service will indicate that you agree to any such changes.
